

Maverik and Teamgive Joe Schmo to Lambo Sweepstakes

May 27, 2010 to October 1, 2011

Official Rules

Maverik, Inc. and Teamgive, LLC, their subsidiaries and affiliated companies (collectively referred to hereinafter as either the “Company” or “Sponsor”) will conduct the Joe Schmo to Lambo Sweepstakes (hereinafter the “Sweepstakes”) substantially as described in these rules, and by participating, each participant agree as follows:

1. Dates of Sweepstakes.

- a. **Ending Date and Starting Date for Sweepstakes:** Sweepstakes will begin on or about 12:00 PM Pacific Daylight Time (“PDT”) May 27, 2010 (“Starting Date”) and end on or about 12:00 PM PDT October 1, 2011 (“Ending Date”).

4. **4th Prize:** At the MMP the following prizes: (i) Hot Lap; (ii) one (1) 2-up Ride; (iii) \$50.00 Karting certificate; and (iv) two (2) 2012 season tickets to the MMP with an ARV of \$1000.00.

5. **5th Prize:** At the MMP the following prizes: (i) Hot Lap; (ii) one (1) 2-up Ride; (iii) \$50.00 Karting certificate; and (iv) two (2) 2012 season tickets to the MMP with an ARV of \$1000.00.
6. **6th Prize:** At the MMP the following prizes: (i) Hot Lap; (ii) one (1) 2-up Ride; (iii) \$50.00 Karting certificate; and (iv) two (2) 2012 season tickets to the MMP with an ARV of \$1000.00.
7. **7th Prize:** At the MMP the following prizes: (i) Hot Lap; (ii) one (1) 2-up Ride; (iii) \$50.00 Karting certificate; and (iv) two (2) 2012 season tickets to the MMP with an ARV of \$1000.00.
8. **8th Prize:** At the MMP the following prizes: (i) two (2) 2012 season tickets to the MMP; and (ii) \$50.00 Karting certificate with an ARV of \$700.00.
9. **9th Prize:** At the MMP the following prizes: (i) two (2) 2012 season tickets to the MMP; and (ii) \$50.00 Karting certificate with an ARV of \$700.00.
10. **10th Prize:** At the MMP the following prizes: (i) two (2) 2012 season tickets to the MMP; and (ii) \$50.00 Karting certificate with an ARV of \$700.00.

b. Finalists and Award of Prizes.

1. Ten (10) finalists (“Finalists”) will be selected from qualifying entries and will be given one (1) key each for a total of ten (10) Finalist keys referred to as Keys 1 through 10 (collectively the “Key(s)”). One (1) of the Keys will win the Grand Prize and the other remaining nine (9) Keys will win one (1) of the other 2nd through 10th Prizes. Odds of winning the Prizes depend on which Key you are given.
2. Finalists will be selected from qualifying entries as provided herein.

c. How to Enter to be Eligible to be a Finalist to be Given a Key for the Prizes:

Only Trail Points of the primary Card holder are eligible for entry.

4. **Key 4 – Maverik Adventure Club Card and how to be given Key 4:** By having or obtaining a Card and going to www.maverik.com, registering your Card, completing the required registration information and opting into the Sweepstakes. One (1) entry will be made for each registered Card upon completion of registration, the required registration information and opting into the Sweepstakes. Additional entries will be made for each “Trail Point” earned for each registered Card commencing from the Starting Date and ending on September 1, 2010. Only Trail Points of the primary Card holder are eligible for entry.
5. **Key 5 – Maverik Adventure Club Card and how to be given Key 5:** By having or obtaining a Card and going to www.maverik.com, registering your Card, completing the required registration information and opting into the Sweepstakes. One (1) entry will be made for each registered Card upon completion of registration, the required registration information and opting into the Sweepstakes. Additional entries will be made for each “Trail Point” earned for each registered Card commencing from the Starting Date and ending on January 1, 2011. Only Trail Points of the primary Card holder are eligible for entry.
6. **Key 6 – Maverik Adventure Club Card and how to be given Key 6:** By having or obtaining a Card and going to www.maverik.com, registering your Card, completing the required registration information and opting into the Sweepstakes. One (1) entry will be made for each registered Card upon completion of registration, the required registration information and opting into the Sweepstakes. Additional entries will be made for each “Trail Point” earned for each registered Card commencing from the Starting Date and ending on Jun 1, 2011. Only Trail Points of the primary Card holder are eligible for entry.
7. **Key 7 – Maverik Adventure Club Card and how to be given Key 7:** By having or obtaining a Card and going to www.maverik.com, registering your Card, completing the required registration information and opting into the Sweepstakes. One (1) entry will be made for each registered Card upon completion of registration, the required registration information and opting into the Sweepstakes. Additional entries will be made for each “Trail Point” earned for each registered Card commencing from the Starting Date and ending on July 1, 2011. Only Trail Points of the primary Card holder are eligible for entry.
8. **Key 8 – Maverik Adventure Club Card and how to be given Key 8:** By having or obtaining a Card and going to www.maverik.com, registering your Card, completing the required registration information and opting into the Sweepstakes. One (1) entry will be made for each registered Card upon completion of registration, the required registration information and opting into the Sweepstakes. Additional entries will be made for each “Trail Point” earned for each registered Card commencing from the Starting Date and ending on

August 1, 2011. Only Trail Points of the primary Card holder are eligible for entry.

9. **Key 9 – Maverik Adventure Club Card and how to be given Key 9:** By having or obtaining a Card and going to www.maverik.com, registering your Card, completing the required registration information and opting into the Sweepstakes. One (1) entry will be made for each registered Card upon completion of registration, the required registration information and opting into the Sweepstakes. Additional entries will be made for each “Trail Point” earned for each registered Card commencing from the Starting Date and ending on September 1, 2011. Only Trail Points of the primary Card holder are eligible for entry.
10. **Key 10 – Maverik Adventure Club Card and how to be given Key 10:** By having or obtaining a Card and going to www.maverik.com, registering your Card, completing the required registration information and opting into the Sweepstakes. One (1) entry will be made for each registered Card upon completion of registration, the required registration information and opting into the Sweepstakes. Additional entries will be made for each “Trail Point” earned for each registered Card commencing from the Starting Date and ending on October 1, 2011. Only Trail Points of the primary Card holder are eligible for entry.

Only one (1) Key may be awarded to one (1) eligible Finalist. No eligible entries may receive more than one (1) Key.

d. No Purchase Necessary Entry – Mail Entries.

In addition to the foregoing methods of entry, including the above no purchase necessary entries included in the description of “How to be given the Keys for the Prizes”, one (1) qualifying entry may be made for the Keys by filling out a 3” X 5” card to include the person’s Name, Address, City, State, Zip Code, Phone Number, and Date of Birth and mailing it with necessary postage to: Maverik and Teamgive Joe Schmo to Lambo Sweepstakes, Maverik Adventure Image Team, 880 West Center Street, North Salt Lake, Utah 84054. No more than one (1) qualifying entry per person. Mail entries must be received on or before the Ending Date.

3. Winners List Request.

Mail must be received by the Winner's List Request Deadline of no later than Ending Date. List will be sent once all Prizes have been awarded.

4. No Automated Entries.

You must fill out your own entry without the use of any automated sweepstakes entry filling services or sweepstakes form filling services. The use of any automated, programmed, robotic or similar system to enter is prohibited and will result in disqualification. Entries filled out by anyone other than you will be disqualified. Auto entries prohibited.

Employees of the Company, the Sweepstake's participating sponsors and their advertising agencies, employees of advertising radio or television stations used for the Sweepstakes, and members of their immediate family of any such persons are not eligible to participate and win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.

5. **Finalist for Key 5:** Finalist for Key 5 will be selected by a random drawing from eligible entries. Odds of winning depend on the number of eligible entries received. Drawing date will be on or before January 21, 2011.

6. **Finalist for Key 6:** Finalist for Key 6 will be selected by a random drawing from eligible entries. Odds of winning depend on the number of eligible entries received. Drawing date will be on or before June 21, 2011.
7. **Finalist for Key 7:** Finalist for Key 7 will be selected by a random drawing from eligible entries. Odds of winning depend on the number of eligible entries received. Drawing date will be on or before July 21, 2011.
8. **Finalist for Key 8:** Finalist for Key 8 will be selected by a random drawing from eligible entries. Odds of winning depend on the number of eligible entries received. Drawing date will be on or before August 21, 2011.
9. **Finalist for Key 9:** Finalist for Key 9 will be selected by a random drawing from eligible entries. Odds of winning depend on the number of eligible entries received. Drawing date will be on or before September 21, 2011.
10. **Finalist for Key 10:** Finalist for Key 10 will be selected by a random drawing from eligible entries. Odds of winning depend on the number of eligible entries received. Drawing date will be on or before October 21, 2011.

7. Finalist Notification and Acceptance of Prizes.

Finalists will be notified by phone within one (1) week of the drawing. If after a reasonable number of attempts during a day (as determined by Company in their sole discretion) contact is not made with winner, prize will be forfeited and an alternate Finalist selected. Finalist is required to sign an affidavit of eligibility and release of publicity/liability ("Affidavit") within the time period specified by Company in the letter accompanying the Affidavit ("Finalist Letter" or "Prize Letter") or Prizes will be forfeited. If mail is returned as undeliverable without a forwarding address, then Prizes will be forfeited. An alternate Finalist and winner for forfeited Prizes may be selected at Company's sole discretion. Finalists and Prizes will be awarded as provided herein and upon receipt of the Affidavit, and verification of Prize Finalist and winner. Winner of the Grand Prize must be a licensed driver and will be required to provide proof of insurance at time of delivery of the Grand Prize. Winner is responsible for title, license, registration, dealer preparation costs, auto insurance and other fees and taxes associated with the Grand Prize. 8. Publicity; Use of Personal Information.

By participating, all participants, Finalists and winner(s) grant the Company exclusive permission to use their names, characters, photographs, voices, and likenesses in connection with promotion of this and other Sweepstakes or contests and waive any claims to royalty, right, or remuneration for such use. By participating in the

Sweepstakes, participants, Finalists and winners(s) agree that the Company may disclose personal information obtained from participants in the Sweepstakes to third parties and use such information for marketing and other purposes.

9. Taxes.

Any valuation of the Prize(s) stated above is based on available information provided to the Company, and the value of any Prize awarded to a winner may be reported for tax purposes as required by law. Each winner is solely responsible for reporting and paying any and all applicable taxes, registration or other expenses related to transfer of the Prize to the winner and paying any expenses associated with any Prize that are not specifically provided for in the official rules. Each winner must provide the Company with valid identification, mailing address, and a valid taxpayer identification number or social security number before any Prize will be awarded. Prizes are not transferable, redeemable for cash or exchangeable for any other Prize. Any person winning over six hundred dollars (\$600.00) in Prizes may receive an IRS form 1099 for the applicable calendar year and a copy of such form will be filed with the IRS.

10. Decisions.

By participating in the Sweepstakes, participants agree to be bound by the decisions of Company personnel. Company reserves the right to disqualify any participant, Finalist or winner and may refuse to award any Prize to a person who is ineligible or who Company believes has violated any rule, gained unfair advantage in participating in the Sweepstakes, or obtained winner status using fraudulent means. Company will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the Sweepstakes and the Company's decisions concerning such disputes shall be final. 12. Live to Give Entry:

Live to Give Entry may be made as follows by going to www.teamgive.com and following the applicable rules as set forth therein and below:

Submissions shall be in the following formats: written submissions, video, photographs and photographic compilations, and music ("Submission"). In order for your submission to qualify for a Live to Give entry, it must meet the following criteria:

Written Submissions: Written Submissions may be submitted in any language. Written submissions may be made in hard copy or in digital format. Digital submissions should be made in PDF format. Submissions should be fewer than 10,000 words; if you would like us to consider a Submission of more than 10,000 words, please indicate the 10,000 word excerpt within your Submission that is most representative of the ideas you wish to communicate. Written Submissions must be the original work product of the submitter. To the extent a Submission contains an excerpt of any other work, such excerpt should be

identified and proper attribution made. If your submission contains an extensive excerpt, please obtain permission from the author prior to making your submission. The theme of the Sweepstakes is “Live to Give,” thus a successful Submission will touch on giving or service in some way. Written Submissions are not limited in format: poetry, essays, screenplays, plays, investigative journalism, academic articles or any other format will be considered. Both fiction and non-fiction entries will be considered. However, in judging Submissions, a preference will be given to those based in fact over those that are not fact based. Similarly, within the non-fiction Submissions, autobiographical Submissions will be preferred over Submissions that report events that happened to third parties with whom the submitter has no relationship.

Video Submissions: Video submissions may be made in any format of your choosing. However, if we cannot play your video, it will not be considered. Consequently we recommend that you submit the video either on a DVD that will play in a standard standalone DVD player, or in a format that can be played by standard video rendering software such as Quicktime[™], Realplayer[™], or Windows Media Player[™] based upon a standard installation and configuration of those programs. Video submissions should generally be shorter than 30 minutes. However, if you would like to submit a video longer than 30 minutes, please identify the short segment of the video that is most representative of the ideas you wish to communicate. Although Video Submissions may contain material that is not original to the individual making the Submission (such as excerpts of news broadcasts, music, photographs, etc.) you must obtain permission from the individuals, businesses, or corporations holding copyright authorization on such works prior to making your Submission.
